The board (the "Board") of directors (the "Directors") of the Company wishes to inform shareholders of the Company ("Shareholders") and potential investors that based on the latest review of the unaudited management accounts (the "Latest Management Accounts") of the Group for the six months period ended 30 September 2022 ("6M2023"), the Group is expected to record a net loss of approximately HK\$4.2 million for 6M2023 as compared to a net loss of approximately HK\$7,000 for the six months period ended 30 September 2021 ("6M2022").

The expected increase in loss was mainly attributable to a combination of (i) the decrease of overall revenue of the Group by approximately 16.6% from approximately HK\$25.3 million for 6M2022 to approximately HK\$21.1 million for 6M2023; and (ii) the decrease of overall gross profit margin of the Group from approximately 40.2% for 6M2022 to approximately 32.8% for 6M2023. The Directors believe that such decreases were mainly contributed by the outbreak of the fifth wave of COVID-19 in early 2022 and the high number of infection cases in the past few months which led to poor market sentiment.

The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the Latest Management Accounts and the information currently available to the Company. Such information has not been reviewed or confirmed by the auditor or the audit committee of the Company. Further details of the Group's performance will be disclosed in the interim results announcement of the Company for 6M2023, which is expected to be published on 7 November 2022.
